**Action Items** All items identified below are for action at the Commission business meeting.

1. T-06.5.PCN (Wayne)

On February 27, 2006 Park City Limousines LC dba Yellowstone Taxicabs, Park City, Utah filed an application for a certificate of public convenience and necessity. That application was noticed to the public on March 7, 2006 and no

protests were received. The applicant has submitted a request to limit the authority, if granted, to seasonal operations.

Class B - Passengers between all points and places in West Yellowstone, Montana and a twenty-five (25) mile radius thereof. LIMITATION: Transportation is limited to service between May 7 and October 7 of each year.

**STAFF RECOMMENDATION:** Approve grant of authority as requested.

2. T-06.6.PCN (Wayne)

On February 27, 2006 Richard L. Robinson dba Granite Disposal, Drummond, Montana filed an application for a certificate of public convenience and necessity. The application was noticed to the public on March 7, 2006 and no protests were received.

Class D – Garbage between all points and places in Granite County. Carrier is allowed to transport authorized commodities to certified landfills from territory authorized. LIMITATION: Use of roll-off containers and/or transfer trailers is prohibited.

**STAFF RECOMMENDATION:** Approve grant of authority as requested.

3. T-06.9.OTSC (Wayne)

On March 17, 2006 an Order to Show Cause was issued to PSC No. 411, Glendive Transfer & Storage company, Inc., Miles City, Montana for failure to reactivate following 12 consecutive months of suspension per 69-12-404 MCA. That Order to Show Cause was mailed certified and received by the carrier on March 21. They have not reactivated the authority.

Class C - Property within the City of Glendive, Montana and to or from points tributary thereto, but within a distance not exceeding 150 miles in any direction from said city. Limitations: (1) Transportation of bulk products, in tank trucks is prohibited; (2) Transportation of oil field equipment, casing or heavy construction equipment is prohibited; (3) Transportation of property requiring the use of special equipment is prohibited; (4) Transportation of property between points served by rail carriers, or between points served by a motor carrier operating between fixed termini or over regular route, is prohibited; (5) Transportation of ashes, trash, waste, refuse, and garbage is prohibited.

SUB A Class B - Household goods (as defined by Commission) from Glendive and points within a radius of 150 miles in any direction from said city to all points and places in the State of Montana and from all points and places in the State of Montana to Glendive and points within a radius of 150 miles in any direction from said city.

SUB B Class B - Household goods (as defined by Commission) from Great Falls and points within a radius of 10 miles in any direction from said city to all points and places in the State of Montana and from all points and places in the State of Montana to Great Falls and points within a radius of 10 miles in any direction from said city.

**STAFF RECOMMENDATION:** Cancel the authority for failure to reactivate.

4. T-06.10.OTSC (Wayne)

On March 17, 2006 an Order to Show Cause was issued to PSC No. 2330, Brown Lines, Inc., Whitefish, Montana for failure to file liability insurance. That Order to Show Cause was sent certified and received by the carrier on March 18, 2006. The carrier has not responded.

SUB B Class B - Persons and baggage in charter service from Kalispell, Montana or from any point in Lincoln or Sanders County, Montana to all points and places in Montana, over irregular routes.

**STAFF RECOMMENDATION:** Cancel the authority for failure to file liability insurance.
