1. T-06.26.PCN _____ (Wayne)

Smooth Moves LLC, Missoula, Montana has requested at their application be withdrawn and the docket closed.

Class B – Household good within the city of Missoula, Montana and a 50 mile radius thereof

STAFF RECOMMENDATION: Withdraw the application and close the docket as requested.

2. T-06.29.ST (Wayne)

On September 21, 2006 Donna S. Miller dba D & D Limousine, Seeley Lake, Montana filed an application for transfer of PSC No. 9449 to Joann Margaret Koepke dba Big Sky Transportation Services, Seeley Lake, Montana. The transfer was noticed to the public on October 17, 2006 and no protests were received.

Class B – Passengers in limousine service (1) between all points and places within Seeley Lake, Montana and a twenty-five (25) mile radius thereof, and (2) between all points and places in Missoula County, Montana with the transportation originating within Seeley Lake, Montana and a twenty-five mile radius thereof.

STAFF RECOMMENDATION: Approve the transfer as applied for.

Valet Limousine LLC, Missoula, Montana as granted a temporary operating authority on October 24, 2006. That temporary authority is due to expire on November 22, 2006. The applicant is requesting a 90 day extension of that temporary authority as allowed under 69-12-207.

4. TN2325 (Wayne)

Kenneth A. Vander Ven dba Lewistown Transfer & Storage Company, Lewistown Transfer and Transfer, Lewistown, Montana requests that the base authority, only, under PSC No. 1122 be reissued for leasing purposes. PSC No. 1122, Sub A and B are being retained by him.

Class B - Household goods (as defined by Commission) between all points in the State of Montana over any public highways.

SUB A Class C - Property in the City of Lewistown, Montana, and to or from points immediately tributary thereto, but within a distance not exceeding ten (10) miles in any direction from said city. Limitations: The transportation of property between points served by rail carriers, or between points served by a motor carrier operating between fixed termini or over a regular route is prohibited. Transportation of ashes, trash, waste, refuse, rubbish and garbage is prohibited.

SUB B Class C - Property within the City of Lewistown, Montana, and to or from points tributary thereto, but within a distance not exceeding fifty (50) miles in any direction from said city. Limitations: Transportation of property between points served by rail carriers is prohibited. Transportation of ashes, trash, waste, refuse, rubbish and garbage is prohibited.

STAFF RECOMMENDATION: Approve the splitting of PSC No. 1122 for leasing purposes.
