On March 24, 2006 Montana Sky's Trucking, Inc., Shepherd, Montana filed an application to transfer PSC No. 304 to MacKenzie Disposal, Inc. dba Go Mini's, Billings, Montana. The application was noticed to the public on April 11, 2006.

Class B - Household goods (as defined by Commission), between all points in the State of Montana over any public highways.

SUB A Class C - Property within the City of Helena, Montana, and to or from points tributary thereto, but within a distance not exceeding ten (10) miles in any direction from said town. Limitations: The transportation of property between points served by rail carriers or between points served by a motor carrier operating between fixed termini or over a regular route, is prohibited. Transportation of ashes, trash, waste, refuse, rubbish and garbage is prohibited.

SUB B Class C - Property in the City of Billings, Montana, and to or from points immediately tributary thereto. Limitations: The transportation of property between points served by rail carriers, or between points served by a motor carrier operating between fixed termini or over a regular route, is prohibited. Transportation of ashes, trash, waste, refuse, rubbish and garbage is prohibited.

SUB C Class C - 1) Major appliances, 2) Television sets, 3) Miscellaneous items such as fireplaces, stereos and related lines from Billings, Montana to all points and places located in the following counties: Glacier, Toole, Pondera, Teton, Hill, Chouteau, Cascade, Lewis & Clark, Missoula, Ravalli, Deer Lodge, Beaverhead, Park, Silver Bow, Madison, Gallatin, Broadwater, Meagher, Judith Basin, Garfield, Wheatland, Sweetgrass, Dawson, Fallon, Custer, Powder River, Rosebud, Big Horn, Treasure, Valley, Phillips, Musselshell, Fergus, Golden Valley, Stillwater, Carbon and Yellowstone. Limitation: Transportation limited to the account of Interstate Distributing Company.
