**Action Items** All items identified below are for action at the Commission business meeting.

1. T-08.33.RI (Wayne)

On July 16, 2008 Titan Enterprises, Inc. dba Diamond cab Company and Diamond Wheelchair Van, Great Falls, Montana filed a rate increase request covering passenger operations conducted under PSC No. 308.

These rate increases were between 10% and 25%. The rate increase was noticed to the public and is not contested.

SUB A Class B - Persons in the City of Great Falls, Montana, and between points tributary thereto, except as noted below. Limitations: Regular or scheduled service as a jitney or bus is prohibited on or over any route.

SUB B Class B - Persons and baggage within the City of Great Falls and a ten (10) mile radius thereof.

SUB C Class B - Persons and baggage between points and places within a 150 mile radius of Great Falls, Montana. Limitations: 1) Transportation must originate at facilities located at the Great Falls International Airport. 2) Transportation is limited to taxi's or vehicles with a maximum seating capacity of six individuals including the driver. 3) Transportation by limousines is prohibited.
