NOTICE OF STAFF ACTION

1. On December 5, 2017, Energy West Montana (“EWM”) filed an Application for Approval of the Reconciliation of West Yellowstone’s No Interest Loan Program (“Application”) with the Montana Public Service Commission (“Commission”). On January 8, 2018, the Commission issued a Notice of Staff Action granting intervention to the Montana Consumer Counsel (“MCC”), and noticed the attorneys representing the MCC and EWM.

2. On January 24, 2018, the Commission issued Procedural Order 7587, which established a variety of substantive and procedural requirements for this Application.

3. Staff amends the remaining deadlines in Procedural Order 7587 as follows:

- (a) June 5, 2018: Final day for EWM and intervenors to file pre-hearing memoranda including identification of data responses to be moved into evidentiary record. *See infra* ¶¶ 19–20.
- (b) June 12, 2018: Final day for EWM and intervenors to object to data responses identified on June 5, 2018. *Id.*
- (c) June 19, 2018: Hearing commences and continues from day-to-day as necessary.

4. The additional requirements in Procedural Order 7587 remain in effect.
