NOTICE OF PUBLIC HEARING

On March 1, 2018, L & L Site Services, Inc. (“L&L”) filed an Application for Certificate of Public Convenience and Necessity (“Application”) with the Montana Public Service Commission (“Commission”). The Application seeks authority for a Class D License, to allow L&L to operate between all points and places within Missoula County, Montana, to a lawful disposal site.

PLEASE TAKE NOTICE that the Commission will conduct a public hearing on L&L’s Application. **The public hearing will commence on May 21, 2018, at 9:00 a.m., in the Castle’s Center in the Alexander Blewett III School of Law, located at the University of Montana, 32 Campus Drive, Missoula, Montana.** The hearing will continue from day to day, as necessary.

The Commission’s jurisdiction over this Application is found in Title 69, of the Montana Code Annotated. The Commission is invested with the full power of supervision, regulation, and control of motor carriers. Mont. Code Ann. § 69-12-201 (2017). Specifically, the Commission has authority for granting Class D Motor Carrier Licenses. *Id* at -314. This hearing is for the purpose of receiving evidence, including testimony and exhibits, concerning the Application. Testimony at the hearing is subject to examination.
